

The team will be available to help with any lastminute needs, concluding the trip with the certainty that it was a memorable experience, full of learning, networking and unforgettable moments.





#### 1. PAYMENT TERMS

#### 1.1 Reservation Deposit

- The reservation will not be considered confirmed until the deposit payment is received and verified in our account.

#### **1.2 Final Payment**

- The remaining balance (50%) must be paid in full at least 60 days (2 months) before the event start date.
- Failure to make the payment within the specified period may result in the cancellation of the reservation and the loss of the deposit paid.

#### 2. CANCELLATION POLICY

#### 2.1 Cancellations with Refund

- Cancellation up to 60 days before the event: 100% refund of the amount paid.
- Cancellation between 21-30 days before the event: 30% refund of the amount paid.
- Cancellation between 0 and 20 days before the event: 0% refund of the amount paid.

#### 2.2 Non-Refundable Cancellations
